6. I will fully and candidly share relevant information, documents, and other materials with other members of the Gas Drilling/Fracking Litigation Group.
7. I will not disclose information of a strategic nature to non-members if such disclosure would compromise the interests of members and their clients who are victims of Gas Drilling/Fracking.
8. I will not share, show, reveal, or disclose any information, documents, index, or materials obtained from the Gas Drilling/Fracking Litigation Group, its members, or the AAJ Exchange, nor will I distribute the information unless ordered to do so by a court of competent jurisdiction.
9. I will notify the Chair or Cochairs of the Gas Drilling/Fracking Litigation Group if any request is made to obtain the Index or any materials obtained from or through Gas Drilling/Fracking Litigation Group, and I will resist such attempts.
