9. I will notify the Chair or Cochairs of the Takata Airbag Defect Litigation Group if any request is made to obtain the Index or any materials obtained from or through Takata Airbag Defect Litigation Group, and I will resist such attempts.

I agree to take the necessary and appropriate action to resist the entrance of a Restrictive Protective Order which forbids or unreasonably restricts the sharing of discovery materials between and among the members of this Group and other attorneys attempting to work together in a common effort to properly prepare individual cases which involve the Takata Airbag Defect.
