7. I understand that I am expected, on a reasonable basis, to share with my colleagues in the Group legal papers, briefs, articles, reports, or other writings. To the extent that any of this information is strategic in nature, I am aware that every effort will be made to maintain the security of such material pursuant to arrangements with which I will be familiar in advance. Naturally, I must reserve the right to appropriately redact or withhold the supply of any documents which would identify the actual names of any client who has instructed me.
